- **SDG's (Agenda 2030)**
- **Security & Migration**
- **Authoritarianism (and closing space)**
- **Post-truth politics**
- **DDD & TWP**

TRENDS IN RESEARCH

- **Several programmes closed (APPP, EPP, ...)**
- **DLP & ESID most relevant**
- **New meta-analysis on economic growth and inequality (Piketty, Deaton, Milanovich, Scheidler)**
- **New action-oriented research (PDIA; How Change Happens; WDR 2017)**

RESEARCH ON INCLUDE PRIORITY
AREAS: (I) ECONOMIC GROWTH

- **Pessimism (Piketty, Deaton) and optimism (Milanovich) on growth and inequality**
- **A surprise from the IMF**
- **The role of industrial policy (Action Aid; Hu-Joon Chang; Mushtaq Kahn)**

RESEARCH ON INCLUDE PRIORITY AREAS: (II) TERRITORIAL DEVELOPMENT

- **Spatial blindness**
- **Increasing (spatial) inequalities (global and national)**
- **Administrative rather than functional approach**
- **Top-down solutions**

RESEARCH ON INCLUDE PRIORITY
AREAS: (III) QUALITY OF GOVERNANCE

- **“Good enough governance”**
- **More participation does not necessarily result in inclusive development**

PERSPECTIVES ON STRATEGIC ACTORS: AGENCY AND INSTITUTIONAL

- **ESID & DLP:**

- Power relations, ideas and incentives are key drivers of inclusion;
- Influencing factors: security; rule of law; leadership, state capacity; alliances

- **WDR 2017:**

- Key factors: elite commitment; coordination between sectors; cooperation of citizens
- Rules of thumb: function vs form of institutions; power asymmetries; rule and role of law

UPTAKE OF NEW INSIGHTS

- **ODI rules of thumb for practitioners:**
 - Problem driven & politically informed
 - Adaptive and entrepreneurial
 - Locally-led
- **DFID:**
 - Uncertainty on context vs uncertainty on intervention
 - Analysis does not always influence intervention

IMPLICATIONS FOR INCLUDE

- **More nuanced understanding:**
 - Inclusive process / inclusive outcomes
 - Competing/conflicting transformations
 - Trade offs
- **How to integrate politics in implementation???**
- **Do we manage to go beyond elites?**
